Discussion: I discussed that the scan surveys for the "Radiological Release Survey Report" dated June 2017 did not appear to meet the survey plan that was submitted in the letter dated June 7, 2016. It did not appear that the alpha scans were done in the same manner and that the scan MDC was not met. I discussed that if they were using something different like area factors which would allow for higher MDC scans then it should be presented, the MDC scan should be calculated with the formula used. Also how the survey performs their scan and when they stop on an alpha scan.
