Labor Services

On June 16, 2017, contract number NRC-HQ-40-17-C-0002 was awarded to CC&C Management Services, LLC in Bethesda, Maryland. The objective of this contract is to provide labor services, administration, and equipment moving support services. The period of performance of this contract is from June 19–30, 2017, with four 1-year options. The potential value over the life of the contract is \$3,460,550.

Decoupling an Assumed Loss of Offsite Power from a Loss-of-Coolant Accident; Discontinuation of Rulemaking Activity and Denial of Petition for Rulemaking (PRM); Part 50 of Title 10 of the Code of Federal Regulations (10 CFR) (Regulation Identifier Number 3150-AH43; NRC-2002-0020 and NRC-2008-0602)

On June 20, 2017, the NRC published a document discontinuing the rulemaking activity, Decoupling an Assumed Loss of Offsite Power from a Loss-of-Coolant Accident, and denying the associated PRM-50-77. The petitioner requested that the NRC amend its regulations in appendix A to 10 CFR part 50, to eliminate the requirement to assume a Loss-of-Coolant Accident coincident with postulated accidents. The rulemaking activity will no longer be reported in the NRC's portion of the Unified Agenda of Regulatory and Deregulatory Actions (the Unified Agenda). Effective June 20, 2017, the rulemaking activity is discontinued and PRM-50-77 is denied.
