Attached please find a copy of the ISI Summary Report for the June, 1995 Inservice Inspection of the Reactor Pressure Vessel and Primary System Piping and their supports at Dresden Nuclear Power Station Unit 2, Illinois State Number B0082800, located in Morris, Illinois. ASME Code, Section XI, 1989 Edition requires this report be submitted 90 days after the startup of the unit from a refuel outage. The unit completed refuel outage D2R14 on April 25, 1996.

The station is owned and operated by Commonwealth Edison Company whose address is: One First National Plaza, Box 767, Chicago, Illinois 60690.

The unit's commercial service date is June 9, 1972, and its gross generating capacity is 834 Mwe. The reactor pressure vessel was manufactured by Babcock and Wilcox Co., and the contractor for the primary system piping was General Electric Co.

The Inservice Inspection was performed from June 5, 1995 to April 25, 1996.

The Authorized Nuclear Inservice Inspector was Robert Rainey from Hartford Steam Boiler Inspection and Insurance Co. of Hartford, Connecticut whose address is: 2443 Warrenville Road, Lisle, Illinois 60532.

The inspections performed, conditions observed and corrective measures recommended and taken, are contained in the attached report.


