The purpose of this letter is to provide additional information to the NRC Staff regarding the net effects of the proposed license amendment (References (a) and (b)) on the Technical Support Center (TSC) Dose calculation, as previously discussed in Reference (a) Attachment A, Section J.

As previously stated in Reference (a), the secondary containment free air volume is an input parameter to the TSC dose calculation, and provides radio-nuclide holdup and mixing prior to release via the Standby Gas Treatment System (SBGT) and up through the chimney. This reduced volume would result in an increase in the dose to personnel in the TSC. However, based on ComEd's Reference (a) amendment and the demonstrated capability of the TSC ventilation system to maintain a positive 1/8 inch W.G. pressure relative to the outside atmosphere, under the current compensatory actions, the TSC dose would be less than the GDC 19 dose limit of 30 REM to the thyroid.
