Generic Letter (GL) 90-03 and Supplement 1 addressed to all power reactor licensees and applicants, requested that addressees review and update their vendor interface programs (VETIP) to reflect guidance provided in the GL.

Our response to the GL was contained in the letter referenced in (c) above. In our response, we committed to perform 5 tasks. Tasks #1 through #4 were required to be performed in order to be in compliance with the GL. Task #5 was not required to be performed by the GL. By letter (reference e above) Commonwealth Edison (ComEd) changed the commitment dates for all actions "requested by the Generic Letter" (i.e., Tasks #1 through #4) to December 31, 1992. By letter references f & g above, the NRC was notified that those tasks had been completed by Dec. 31, 1992.


The purpose of this letter is to rescind our commitment to perform periodic recontact of non-safety-related vendors (Task #5), which is not required by the GL.
