NRC Radioactive Materials License No. 06-30556-01, Amendment No. 08: Update to License Use in Areas of Exclusive Federal Jurisdiction at Site WR111, Hill Air Force Base, UT

Cabrera Services Inc. (Cabrera) is providing this written notification updating the status of temporary work activities at Hill Air Force Base (Site WR111). The following information is provided in accordance with License Condition No. 18B:

- Temporary job site status: Cabrera performed soils excavation and final status survey (FSS) gamma scans & soil sampling at Site WR111. Temporary job site controls were removed at the completion of remediation and after a review of gamma walkover survey results by Cabrera Health Physicists (HP). A locked chain-link fence remains in place pending review of off-site sample analytical results and transfer of the Site back to the Owner. Additional FSS may be conducted, if required to meet FSS data objectives. Otherwise, no other licensed activities are currently planned for the Site.
- Disposition of any licensed radioactive material: A total of 133 tons of radioactive material containing natural thorium were excavated and transported by dump truck to the US Ecology landfill in Grand View, Idaho for disposal.

An additional update or termination notice will be submitted when control of Site WR111 is returned to the Owner or additional soil remediation is scheduled based on FSS results. If you should have any questions, please contact me at (352) 610-2150.
