Amendment No. 13 to your NRC License No. 13-32194-01 was generated using a new Web-Based Licensing System. In accordance with NRC policy, we have deleted Condition No. 13 regarding the need for decommissioning financial assurance. We have also deleted Condition No. 14 and included the reference to Title 10 of the *Code of Federal Regulations* (CFR), Part 71, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license.

You will be periodically inspected by NRC. The NRC may issue a notice of violation, imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
