The U.S. Nuclear Regulatory Commission (NRC) staff is preparing a safety evaluation (SE) with no open items (OIs) for each chapter of Revision 2 to the Advanced Power Reactor 1400 Design Certification Application, submitted by Korea Electric Power Corporation and Korea Hydro & Nuclear Power Co., Ltd. (KHNP) on March 8, 2018.

The staff's SE with No OIs for Chapter 6, "Engineered Safety Features," is being provided to the Advisory Committee on Reactor Safeguards (ACRS) Subcommittee to support on upcoming meeting of the ACRS Subcommittee, scheduled to be held on June 19, 2018.

The enclosed SE with no OIs is being provided to KHNP for review of proprietary information pursuant to the Title 10 of the *Code of Federal Regulations* 2.390, "Public Inspections, Exemptions, Requests for Withholding." The staff concludes that the enclosed SE does not contain any information for which exemption from public disclosure has been sought or approved; however, the NRC will withhold the enclosed SE from public disclosure for ten business days from the date of this letter to allow you the opportunity to verify the staff's conclusion that the SE contains no exempt information or factual errors. If within that ten day period, you do not request that all or portions of the SE be withheld from public disclosure, the enclosure will be made available for public inspection through the Publicly Available Records component of NRC's Agencywide Documents Access and Management System and placed on the NRC's public web page for this application.
