General Comment

A. "Should NRC require an activity-based patient release threshold under which patients would be required to be maintained in a clinic-sponsored facility (e.g., a medical facility or facility under the licensee's control) until the standard for release is met."

Yes. It is a lot for a patient to deal with the thyroidectomy and then RAI. If on medication withdrawal, we do not feel well AT ALL for weeks and have memory issues. A facility that will monitor the safety of others and the patient would be ideal. As well as providing everyday comforts that are safely disposed of by the facility. The patient is going through enough..
