However, NuScale DCD Tier 2 Section 9.3.6, "Containment Evacuation System and Containment Flooding and Drain System," does not identify or provide reference to this exemption.

The applicant should update NuScale DCD Tier 2 Section 9.3.6 to identify and provide reference to Exemption No. 13.
