On April 27, 1998, the NRC completed an inspection at your Dresden Nuclear Power Station, Unit 2. The results of the inspection were discussed with Mr. Mike Heffley and other members of your staff on April 27, 1998. The enclosed report presents the results of this inspection.

The purpose of the inspection was to review the implementation of the inservice inspection program for the Dresden Unit 2 refueling outage 15. In addition, this inspection also reviewed activities associated with your installation of the emergency core cooling system suction strainers.

We concluded that, overall, the implementation of your inservice inspection program met ASME, Section XI requirements. The areas examined during the inspection are identified in the report.
