Norma,

Thank you for the opportunity to review the draft Certificate of Compliance (CoC) for the RAJ-II package. As requested, attached please find the consolidated GNF comments on the draft CoC. All suggested changes are shown via Track Changes with the review name of 'Lisa Schichlein'. Some items to note:

- We are in agreement with your intent to simplify the tables
- The only technical change made to the CoC is in the Fuel Rod Pitch values in Table 3. Since the word 'Nominal' has been deleted from the Parameter name, the values were adjusted to be consistent with the values in Table 6-1 of the SAR.
- In the References section at the end of the CoC, the July 17, 2014 date should be deleted. That date refers to the submittal of Revision 7.1 of the RAJ-II SAR to the NRC. All elements of Revision 7.1 have been incorporated into Revision 9 of the RAJ-II SAR. I also embedded a comment to reflect this statement.
