2 | During normal unit startup, CRD C-11 was tested for overtravel. The overtravel alarm

3 | came up and rod position indication was lost. This was of minimal safety significance,

4 | since the rod was inserted to position "00" and electrically disarmed. There was no

5 | effect on public health or safety. Previous uncoupling of CRD C-11 during this cycle

6 | was reported by Licensee Event Report 80-09/03L.
