Dear Ms. Griffin:

Enclosed is Amendment No. 12 to your NRC Material License No. 13-20664-01 in accordance with your request. Please note that the format of your license has changed due to updates to our licensing process.

Please note that Items 6-9 on your license have been updated in accordance with the information provided and the applicable Sealed Sources and Devices Registries. Although the physical inventory provided did not list Accuray Corporation model U-6 and U-8 devices, additional information was not provided to confirm they had been disposed of or transferred to another licensed person or organization. Multiple attempts were made to contact Ms. Griffin regarding this issue and a response was not received. Due to lack of certainty regarding the status of the devices the decision was made that the Accuray Corporation Models U-6 and U-8 source holders will remain on the license until additional information is provided.

Additionally, note that Condition 23 (on your previously issued license) regarding Transportation requirements has been removed as these requirements are fully contained within the provisions of 10 CFR Part 71, "Packaging and Transportation of Radioactive Material."

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. You can access the policy statement and supporting material that may benefit your organization on NRC's safety culture
