Dear Mr. Sullivan,

This is in reference to the Agreement of Resignation, Appointment and Acceptance dated March 8, 2017, by and among Cardinal Health 414, LLC and the U.S Bank National Association. This document was submitted for the change of trustee from JPMorgan Chase Bank and U.S Bank National Association to support financial assurance for Nuclear Regulatory Commission License No. 34-32780-02, Docket No. 03038331 and License No. 34-32780-01, Docket No. 03038222. In order to continue our review, we need the following additional information.

On page 1 of the document in the "Recitals" section, the governing instrument is stated as the Standby Trust Agreement dated September 30, 2011. This instrument had been returned to you from us in a letter dated April 30, 2012 (ML12123A691) as the Standby Trust Agreement was superseded with an Amended and Restated Standby Trust Agreement dated March 15, 2012 (ML12083A116). It appears that the governing Instrument should be the Standby Trust Agreement dated March 15, 2012. It is also noted that the March 15, 2012, Standby Trust Agreement was the instrument which was stated in the Exhibit C of the Agreement of Resignation, Appointment and Acceptance document dated March 8, 2017. Please provide an amendment document stating the governing instrument as the Amended and Restated Standby Trust Agreement dated March 15, 2012, or provide an explanation why the "governing instrument" should be the September 30, 2011, document which was restated in on March 15, 2012.
