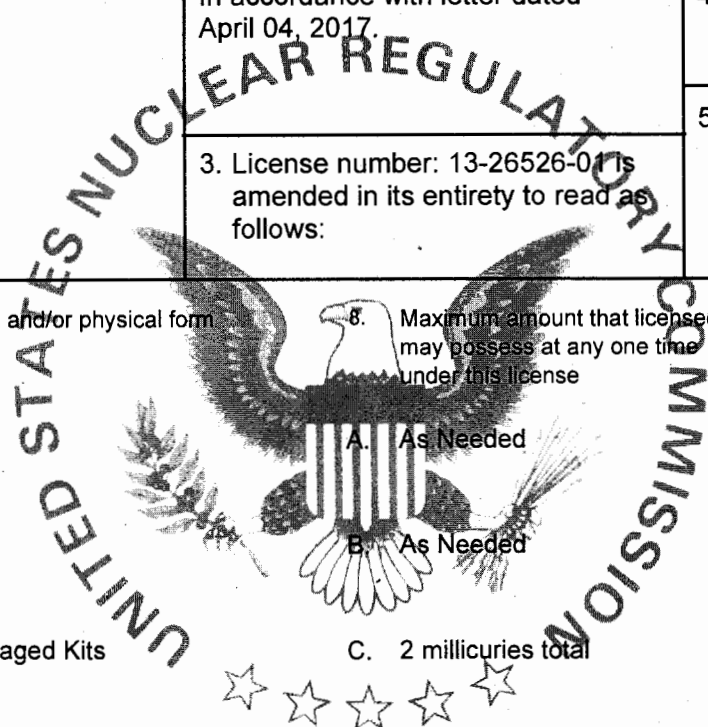


MATERIALS LICENSE

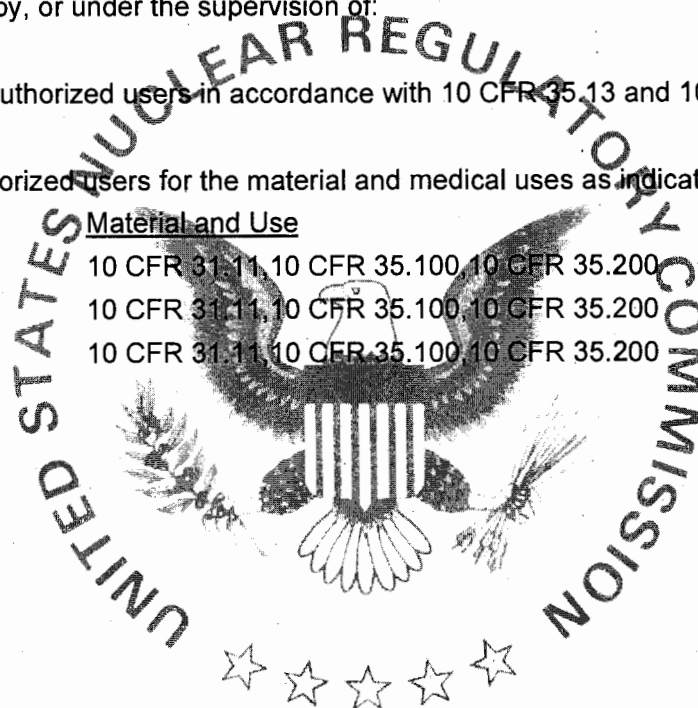

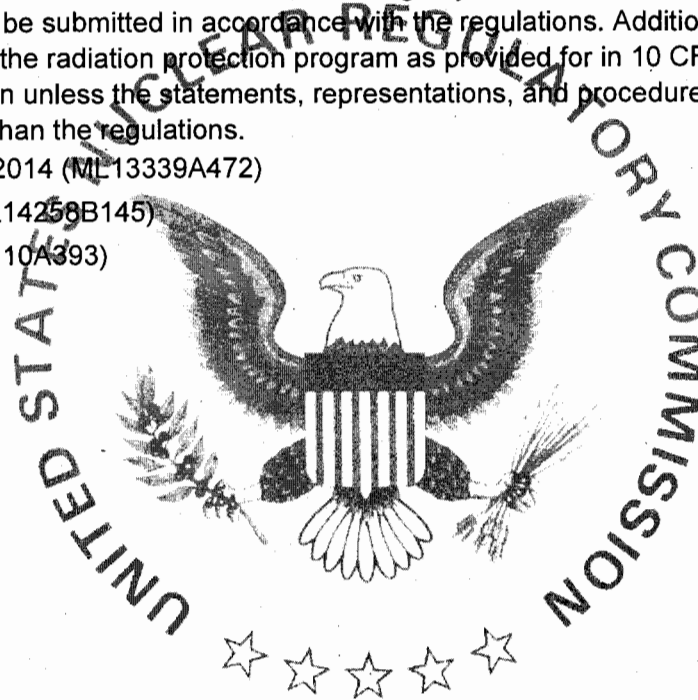
