
Gentlemen:

This confirms our revised plans as discussed on October 26, 1982, between Mr. L. O. DelGeorge of your staff and Mr. J. A. Grobe of this office to conduct an Enforcement Conference with you and members of your staff at 10:00 a.m. (CST) on November 3, 1982, at the Commonwealth Edison Company Office in the First National Bank Building, Chicago, Illinois. This Enforcement Conference relates to the quality assurance aspects associated with the procurement, installation and use of non-qualified valve guides in the electromatic relief valves used at the Dresden and Quad-Cities Nuclear Power Stations. This revision from our previous plans in our October 4, 1982, letter to you is a change in the location of the Enforcement Conference.

This also confirms our plans to conduct a Management Meeting with you and members of your staff at 12:30 p.m. (CST) on November 3, 1982, to discuss the results of the investigation of drug related allegations at the Zion Nuclear Power Station.
