Amendment Number 67 to your U.S. Nuclear Regulatory Commission (NRC) License Number 24-02261-03, issued on August 6, 2015, reduced the possession limit of radioactive material authorized in Subitem D. of your license to below the threshold that requires financial assurance. Since decommissioning financial assurance is no longer required, we have cancelled the following financial assurance instruments and required supporting documents: (1) Letter of Credit valued at \$338,000 dated April 23, 2007 (two copies); (2) Amendment No. 1 to Letter of Credit dated January 28, 2010; (3) Standby Trust Agreement dated April 20, 2007 (two copies); and (4) Amendment No. 1 to Standby Trust Agreement dated October 29, 2009. The cancelled documents are enclosed for your records.

In accordance with Title 10 of the *Code of Federal Regulations* (CFR) 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC's Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
