Dear Ms. Bell:

Enclosed is Amendment No. 90 to your NRC Material License No. 13-06009-01 in accordance with your request.

If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In the future, please note that we would find it helpful for you to include information confirming that each proposed Authorized User (AU) is currently licensed by a state to practice medicine, in accordance with the definitions in 10 CFR 35.2.

Most of the following is repeated from my letter to you dated December 29, 2016, which we have not received a response to yet, although we requested a response by January 29, 2017.

As stated in NUREG 1556, Vol. 9, Rev. 2, Section 9 on page 9-1, "Licensees are responsible for applying for amendments to licenses and for keeping them up-to-date."

It appears that your license authorizes two HDR devices, although only one is actually in use. If the old HDR device and sources have been permanently disposed of from this license, it is incumbent upon you to update the license accordingly. If you only have one HDR device, then your license is incorrect and authorizes this device and its sealed sources incorrectly. You must rectify this situation.

In reviewing some of your license's history, it appeared that the old HDR device and sources may have been permanently disposed of in 2015, more than one year ago. If this is not the case, please contact me.

If this is, in fact, the case, please submit an appropriate amendment request within 30 days of the date of this letter requesting the permanent removal of your old HDR device and sources.

If you are unsure of the information needed to effect this removal, please contact me to discuss this. If an alternative timeframe is needed for response, please contact me to discuss that also.

The enclosed document contains sensitive security-related information.
When separated from this cover letter this letter is uncontrolled.

I also noted that your letter dated August 25, 2015, in item 5, refers to a statement made in your application dated December 23, 2013, concerning commitments made in Amendment No. 81 dated "July 12, 2012."

Amendment No. 81 to your license was dated July 16, 2012. Please correct this in your response also when submitting the information to remove the old HDR device and sources from your license.

Please address your responses to my attention as "additional information to control numbers 594555 and 592087."

In addition, if there are any other authorizations on your license that are no longer in practice, please contact me and request amendment to your license to remove them also.

For example, it is not clear whether the Proxima GliaSite RTS is still being manufactured and used. If it is not, please request an amendment to remove this authorization from your license. Please contact me if you have questions while preparing the amendment request.

Please ensure that a senior management official signs this amendment request, in accordance with 10 CFR 35.12(a) and 10 CFR 35.2.


