This letter refers to your license amendment request dated May 26, 2017. Please find enclosed Amendment No. 53 authorizing Daniel Adam Rodgers as an authorized user for all activities of sodium iodide iodine-131 permitted by 10 CFR 35.300.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).


