Dear Mr. Murley:

Pursuant to 10 CFR 50.90, Commonwealth Edison proposes to amend Appendix A, Technical Specifications to the Facility Operating Licenses identified above. The proposed change will remove the Commonwealth Edison Corporate and Station organization charts from the Technical Specifications. The NRC previously approved a similar change for the McGuire Nuclear Station, Unit Nos. 1 and 2 on March 19, 1986, Zion Nuclear Station, Unit Nos. 1 and 2 on March 26, 1987, and Shearon Harris Nuclear Power Plant, Unit 1 on January 27, 1988.

The content required in the Administrative Controls Section of the Technical Specifications is specified in 10 CFR 50.36.c(5). The regulation requires that the Technical Specifications contain the controls and provisions that are necessary to assure operation of the facility in a safe manner and does not specifically require inclusion of the organization charts in the Technical Specifications.

Previously, organizational changes would have resulted in the Company's processing and the NRC's review of unnecessary license amendments. Consistent with the NRC and industry commitment to improve Technical Specifications, Commonwealth Edison proposes to delete the organization charts from the Technical Specifications for Dresden, Quad Cities, and LaSalle County Stations. Deletion of the organization charts will eliminate this needless expenditure of resources for both organizations.




