Dear Mr. Seufert:

Enclosed is Amendment No. 10 to your NRC Material License No. 21-32172-01 in accordance with your request.

During our review of your license, we found that the licensed material listed in your license meets the requirements set forth in 10 CFR 30.35, "Financial assurance and recordkeeping for decommissioning". Specifically, your licensed possession limit is greater than 10^5 times the applicable quantities of Appendix B to 10 CFR Part 30. We discussed this matter with you via a telephone conference on July 10, 2017 and via an electronic mail on July 11, 2017. Please review your current inventory and future use and provide an amendment request to reduce the possession limit to below the requirement for establishing a decommissioning financial assurance or provide a decommissioning financial assurance in accordance with 10 CFR 30.35. Please provide a response to the above within 60 days from the date of this letter. For your reference, the guidance to provide a decommissioning financial assurance and/or decommissioning funding plan is NUREG-1757 which you can find at <https://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1757>.

Please note that your license format has been changed based on our new licensing process (Web-Based Licensing). In addition, in accordance with the licensing policy we updated License Condition No. 14 regarding the authorization for decay-in-storage. We also deleted License Condition No. 16 regarding the transportation requirements because the requirements are already listed in the regulations under 10 CFR Part 71.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

When separated from this cover letter this letter is uncontrolled.


