This refers to your license amendment request dated April 13, 2017. Please find enclosed Amendment No. 14 authorizing Kevin Gibbs as Radiation Safety Officer. At this time your request to increase the amount of activity on your license has not been approved because you have not yet submitted a new certification of financial assurance. When the certification of financial assurance is received the request to increase the activity on your license will be processed under a new control number.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(10).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
