Premier Healthcare, LLC would like to provide additional information (control number 599820) regarding the notice of a transfer of control of its Byproduct Materials License, Number 13-32020-01, to IU Health Southern Indiana Physicians. The name of the licensee will now be IU Health Southern Indiana Physicians Cardiology. Additional information in support of this change is enclosed below:

1. The Premier Healthcare group was acquired by IU Health Southern Indiana Physicians through a sales transaction whereupon all assets and liabilities were purchased, and whereupon the group is now doing business, under the IU Health Southern Indiana Physicians Tax ID. This acquisition is effective May 1, 2017. All existing certifications and licenses have been, or are being, transferred to the current owner, IU Health Southern Indiana Physicians. Please contact Elizabeth Thompson at 812-353-4817 for any additional questions regarding the acquisition. **Please note that IU Health Southern Indiana Physicians does not currently hold an NRC license nor have they held a license in the past.**
2. The Chief Executive Officer for the licensee will now be Elizabeth Thompson. The Medical Director and Authorized User for the license will be Dr. Jennifer Petersen Goldspiel. Dr. Petersen Goldspiel is currently listed as an Authorized User on the license of Indiana University Health Bloomington Hospital, NRC license number 13-10408-02. Additionally, Dr. Gregory Sutliff will no longer be working at the facility and can be removed from the license. No changes will be made to technical staff or the RSO position.
3. There will be no changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.
4. The current surveillance program meets NRC guidelines and no changes in status will occur with the transfer of control.
5. Records concerning the safe and effective decommissioning of the facility will be transferred and maintained by the transferee.
6. The transferee will abide by all constraints, conditions, requirements, and commitments of the transferor.
