The following information is supplied in response to your letter of September 17, 1979.

Calculations have been performed to demonstrate that, when compliance with present technical specification limits is maintained, Florida Power & Light Company is in compliance with 10 CFR 50 Appendix I. Based on NUREG 0133 and NUREG 0472, compliance with Appendix I ensures conformance with the provisions of 40 CFR 190. Therefore, compliance with our existing technical specifications will demonstrate conformance with the provisions of 40 CFR 190 until revised Radiological Effluent Technical Specifications are issued.
