It is our understanding that the sale took place on June 1, 2017; but that the license and the materials subject to the license were specifically excluded from the assets transferred and will not be transferred until NRC's consent is received. Please confirm this understanding and indicate the date that the change of control of the license is expected to occur. You may also confirm that the change of control of the license will happen immediately following the NRC approval.

Response: Your understanding is correct. The change of control of the license will happen immediately following NRC approval.

4. Please describe any planned changes in the organization, change in members on the Board of Directors, etc. Please confirm if Michael J. Caruso will remain the Ohio Valley Medical Center President and CEO. If not, please indicate who the senior administrative contact will be for the license.

Response: Ohio Valley Medical Center previously had a Board of Directors but as of June 1, 2016, the operations of Ohio Valley Medical Center are overseen by Alecto Healthcare Services LLC as the manager of Alecto Healthcare Services Wheeling LLC. Alecto Healthcare Services Wheeling LLC is now the licensed (by the State of West Virginia) operator of Ohio Valley Medical Center. The Board of Managers of Alecto Healthcare Services LLC consists of Lex Reddy, Roger Krissman, and Michael Sarrao. Mr. Caruso is no longer CEO. Lex Reddy is currently serving as the CEO of Ohio Valley Medical Center and responsible for controlling the license and making day to day decisions. Mr. Reddy's contact information is as follows:


