NO. 3 FOR THE HI-STORM FLOOD/WIND MULTIPURPOSE CANISTER
STORAGE SYSTEM

Dear Ms. Manzione:

Holtec International (Holtec) submitted an amendment request to the U.S. Nuclear Regulatory Commission (NRC) to revise Certificate of Compliance (CoC) No. 1032 for the HI-STORM Flood/Wind (FW) Multipurpose Canister Storage (MPC) Storage System in a letter dated December 18, 2015 (Agencywide Document Access and Management System (ADAMS) Accession No. ML15364A561). Holtec modified its request on April 22, 2016 (ADAMS Accession No. ML16113A398), and supplemented it on June 22, 2016 (ADAMS Accession No. ML16180A360) and August 22, 2016 (ADAMS Accession No. ML16236A243). The amendment:

1. Includes burnup credit for fuel types in the MPC-37.
2. Revises CoC Condition 8, which has been previously incorporated in Amendment No. 2 to CoC No. 1032.

This amendment, when codified through rulemaking, will be denoted as CoC No. 1032, Amendment No. 3.

As stated in the *Federal Register* (82 FR 29225, 6/28/17), the effective date of this CoC is September 11, 2017. The NRC's safety evaluation report for this CoC, including Appendices A (technical specifications) and B, are enclosed. This certificate constitutes the approval and conditions for use of HI-STORM FW MPC Storage System for storage of spent nuclear fuel under the general licensing provisions of 10 CFR 72.210.
