### NOTICE OF ISSUANCE OF AMENDMENT TO FACILTY OPERATING LICENSE NPF-16

Pursuant to the Commission meeting held on June 10, 1983, the U.S. Nuclear Regulatory Commission (the Commission), has issued Amendment No. 2 to Facility Operating Licene No. NPF-16, issued to Florida Power & Light Company, Orlando Utilities Commission of the City of Orlando and Florida Municipal Power Agency (licensees) for the St. Lucie Plant, Unit 2 (facility) located at the licensees' site on Hutchinson Island in St. Lucie County, Florida. This amendment is effective as of the date of issuance.

This amendment authorizes operation at power levels up to 100% of full rated power, 2560 megawatts thermal, in accordance with the provisions of the License as amended, the Technical Specifications as amended, and the Environmental Protection Plan.

Issuance of the amendment complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's regulations. The Commission has made appropriate findings as required by the Act and the Commission regulations in 10 CFR Chapter I, which are set forth in the license amendment. Prior public notice of the overall action involving the proposed issuance of an operating license authorizing full power operation was published in the FEDERAL REGISTER on March 9, 1981 (46 F.R. 15831).
