On July 25, 2017, the U.S. Nuclear Regulatory Commission (NRC) published a document in the *Federal Register* ([82 FR 34387](#)) correcting a direct final rule that appeared in the *Federal Register* on March 24, 2017 ([82 FR 14987](#)), that amended NRC's spent fuel storage regulations by adding the TN Americas LLC, NUHOMS® Extended Optimized Storage Dry Spent Fuel Storage System to the "List of approved spent fuel storage casks" as Certificate of Compliance No. 1042. This action is necessary to correct the certificate expiration date. The correction is effective July 25, 2017.

**Differing Professional Opinion Regarding Palo Verde Nuclear Generating Station License Amendments**

On June 28, 2017, the Director, Office of Nuclear Reactor Regulation (NRR) issued a decision on two Differing Professional Opinions (DPOs) submitted on December 28, 2016, and January 9, 2017, concerning two emergency license amendment requests submitted by Palo Verde Nuclear Generating Station (PVNGS) that were approved by the NRC related to diesel generator allowed outage time. The DPOs raised concerns that the approval of the emergency license amendments was inconsistent with the NRC Mission, NRC Vision, NRC Safety Objectives, NRC Effectiveness Strategies, NRC Openness Strategies, and the Principles of Good Regulation. On June 5, 2017, an Ad Hoc Panel (Panel) provided the results of its independent review of the DPOs to the Director, NRR. The Panel was not unanimous in concluding that the PVNGS license amendments should have been approved by the staff. The Panel was unanimous in concluding that additional guidance is needed in several areas for reviewing emergency license amendment allowed outage time extension requests for inoperable diesel generators, as well as guidance for deterministic license amendment requests with supplemental risk information, how and whether precedents should be used, and how and whether independent verification using independent risk tools should be used. The Panel also made eight recommendations to help clarify guidance to the staff. The Director, NRR, agreed with the Panel on the conclusions and on seven of the eight recommendations. Aspects of the DPO not directly related to the PVNGS amendments (e.g., comments regarding staff training and ROP effectiveness) will be considered as part of the staff's annual ROP review.
