Dear Mr. Lee:

Receipt is acknowledged of your July 31, 1972 submittal of "Benefit-Cost Analysis Report for Dresden Units 2 and 3, Docket Numbers 50-237 and 50-249". The report is being reviewed for technical adequacy.

Your request that the report be regarded as having been submitted in Docket No. 50-237 as well as in Docket No. 50-249 is approved. Additional copies are not required at this time.

Regarding the NEPA review for Dresden Unit 2, a separate environmental report is required. For those portions of the Dresden 2 Environmental Report that would duplicate the information presented in the Dresden 3 Environmental Report, reference to the Dresden 3 Report is sufficient. There are, however, matters that are or might be unique to Dresden 2 and should be explicitly discussed in the Dresden 2 Environmental Report. Examples of such matters include: a listing and status of all Federal, State, and local permits and approvals for construction and operation; design differences; operating procedure differences; and operating experience with respect to environmental matters (thermal discharge, radioactivity release, fogging, noise, etc.).

We intend to prepare a single statement covering the environmental impact of both Dresden 2 and Dresden 3. Preparing a single statement will realize a significant saving in time and effort. Since the preparation of the single statement has already started, it would be most helpful if the environmental report for Dresden Unit 2 as described above is submitted by October 23, 1972. You are requested to furnish three signed originals and 197 copies of the Dresden 2 Environmental Report. Please hold 100 additional copies subject to call by the AEC.
