SUBJECT: SAFETY PARAMETER DISPLAY SYSTEM

The staff has completed its review of your submittals dated February 3, 1984 (L-84-27), March 1, 1984 (L-84-48 and L-84-49), November 2, 1984 (L-84-285) January 14, 1985 (L-85-19), and April 9, 1985 (L-85-137) dealing with the Safety Parameter Display System (SPDS) on St. Lucie Plant, Unit Nos. 1 and 2.

The results of the staff's review are contained in the enclosed Safety Evaluation. (SE). As indicated in the SE, there is a need for additional information of a confirmatory nature concerning parameter selection. The information required is detailed in Section III.B of the SE. The review of this information will be conducted as a plant specific review. Your action on all other requirements of TMI Action Item I.D.2 are considered acceptable. Based on the staff's evaluation of your submittals, it is concluded that no serious safety questions or inadequacies are posed by the proposed SPDS and, therefore, it is acceptable for you to continue implementing your SPDS program. The conclusion that SPDS implementation may continue does not imply staff confirmation that the SPDS meets the requirements of Supplement 1 of NUREG-0737. Such confirmation can be made only after a post-implementation audit or when the staff has otherwise obtained sufficient information.

It is requested that you provide the additional information requested in the SE within 30 days of your receipt of this letter or provide a date that you can meet within 15 days of receipt of this letter.

The staff review was conducted under its TAC Nos. 51285 and 51286. These TACs have now been administratively closed and new TACs will be assigned when you provide the information concerning parameter selection.
