In accordance with 10 CFR 50.90, Florida Power & Light Company (FPL) submits herewith three signed originals and forty copies of a request to amend Facility Operating License DPR-67.

The proposed amendment deletes the Core Barrel Movement Technical Specifications 3.4.11, 4.4.11.1 through 4.4.11.3, and Bases 3/4.4.11. A "Determination of No Significant Hazards Consideration" is provided as Attachment 3.
