Hello Mr. Lawyer,

I'm following up on our phone discussion, during which you sought additional information regarding License Condition 13 in Plus LLC's exempt distribution license (06-35274-01E). As requested, I've attached a copy of the required certificate, which includes certifications regarding manufacturing standards and quantities of tritium for imported timepieces. I issue this certificate as the RSO on behalf of the licensed importer, Plus LLC, whenever a shipment is received in the U.S. There is also a corresponding joint Certificate of Conformity Compliance signed by the importer and exporter. When shipments are received, I personally conduct visual tests and drop tests (as demonstrated to you during the site inspection). I am assured of compliance with ISO and ANSI standards because I have verified the current ISO 9001:2008 certification of mb-microtec, the manufacturer of the GTLS (attached), and the visual/drop/leak test results recorded by the foreign-based exporter, Mirnar Industries, for the lot. These tests are conducted per 8.3.2 ANSI N43.4 to a max of 50 nCi T per 24 hours, and records are maintained of the tested lots to trace the watches imported into the U.S. back to these lots.
