Enclosed is Amendment No. 24 to your NRC Material License No. 24-32462-01MD in accordance with your request.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that we have prepared your amendment with our new Web Based Licensing system (WBL). Several minor updating and formatting changes are reflected in this amendment but none should have an impact on your licensed program.

We also deleted Condition Nos. 18 and 19 from your license, as they appeared on Amendment No. 23, because No. 18 was no longer necessary for your license and we added language in the Preamble at the top of page 1 of your license to reference 10 CFR Part 71 instead of continuing with Condition No. 19.

We completed some missing wording in Condition No. 15 and modified the wording in Condition No. 18.A. to more correctly identify this document.


