The purpose of this modification is to exercise option year one, thereby increasing the contract ceiling by [REDACTED], providing incremental funding in the amount of \$270,000.00, and extending the period of performance by 12 months. The contract is revised as stated below.

1. Clause NRCB084 CONSIDERATION AND OBLIGATION- LABOR-HOUR CONTRACT is revised to the following:

“(a) The ceiling price to the Government for full performance under this contract is [REDACTED]. The total amount obligated under this contract is \$795,000.00.

(b) The contract includes direct labor hours at specified fixed hourly rates, inclusive of wages, fringe, overhead, general and administrative expenses, and profit.

(c) It is estimated that the amount currently obligated will cover performance through [REDACTED].
