Florida Power & Light Company (FPL) letter L-88-238, dated May 24, 1988 provided a plan for the St. Lucie Unit 1 Simulation Facility. Discussion with the NRC Staff has indicated that St. Lucie Unit 1 could be certified to St. Lucie Unit 2 Referenced Plant Simulator. As provided on NRC Form 474 "Simulation Facility Certification" exception would be taken in these areas:

- 1) St. Lucie Unit 2 procedures would be utilized for simulator training;
- 2) The configuration differences between Unit 1 and 2 will be reviewed and incorporated as appropriate in the training program. The simulator configuration would be validated against Unit 2 only;
- 3) Unit 2 performance testing would be referenced for modeling the response for Unit 1.

FPL concurs with this method and will plan to certify St. Lucie Unit 1 to the St. Lucie Unit 2 Reference Simulator.

The FPL simulator for St. Lucie was delivered in the fall of 1987 and operator training began in May 1988. FPL expects to submit certification packages for St. Lucie Units 1 and 2 by March 1991.
