SUBJECT: RII 90-A-0039 - ALLEGATION

As discussed in a March 26, 1990, telephone conversation between Mr. M. Sinkule of my staff, and Mr. D. Sager of your staff, this letter is in reference to an allegation received by the NRC. The enclosure to this letter provides the details relative to this issue.

The NRC has not made an attempt to ascertain the accuracy or validity of the information supplied by the informant.
