Dear Mr. Reddy:

By the letter dated May 12, 2017, Ohio Valley Medical Center (OVMC) requested written consent by the U.S. Nuclear Regulatory Commission (NRC) to a proposed direct transfer of control of NRC Materials License No. 47-17282-01 (ADAMS Accession Number ML17139D326). Based on the information you provided, we understand that as a result of the sale of substantially all of the assets of Ohio Valley Medical Center to Alecto Healthcare Services Ohio Valley LLC (AHSOV), Alecto Healthcare Services Wheeling LLC (AHSW), and Alecto Healthcare Services Martin's Ferry LLC (AHSMF), control of Ohio Valley Medical Center will be directly transferred to Alecto Healthcare Services Wheeling LLC. After the sale, OVMC will be owned and operated by AHSW, whose parent company is AHSOV. The licensee will be known as Alecto Healthcare Services Wheeling LLC d/b/a Ohio Valley Medical Center.

We understand that this transfer will not result in any change to the location of use, materials, persons using licensed material, or persons responsible for radiation safety at the licensed facility.

Based on the above understandings, as more fully detailed in the enclosed Safety Evaluation Report that documents the NRC staff's safety review of the request, and in accordance with 10 CFR § 35.18, the NRC approves the proposed transfer. An environmental assessment for this action has not been prepared by the NRC, because this action is categorically excluded under 10 CFR 51.22(c)(21).

Please find enclosed Amendment No. 48 authorizing the licensee name change to Alecto Healthcare Services Wheeling LLC d/b/a Ohio Valley Medical Center. We understand that substantially all of the assets of Ohio Valley Medical Center were purchased on June 1, 2017, but the license and the materials subject to the license were specifically excluded from the assets transferred, and that portion of the sale will occur immediately following NRC's written consent to the license transfer. The amended license will become effective on the date of transfer, but no later than 30 days after the date of this approval letter. Please note that you will need to notify us promptly, in writing, after the transaction has been finalized and include a signed copy of the sales agreement confirming completion of the transaction. If this planned sale has not been consummated within 30 days of the date of this letter, please notify us in

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions of the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

Future changes in the licensee's name, licensed use, licensed materials, licensed location, or persons responsible for licensed material require submission of a request to amend the license. NRC approval must be received prior to implementation of the proposed change.


