The Nuclear Regulatory Commission Region II is pleased to announce that an Incident Response Workshop has been arranged for NRC power reactor licensees, Regional Federal agencies, and States. The specific target audience is utility EOF Managers, Site TSC Managers, Public Affairs representatives, and Site Emergency Planners. The workshop will be held on April 30 and May 1, 1991, at the Omni International Hotel in Atlanta, Georgia. The purpose of the workshop is to improve communications between the NRC, licensees, and other governmental organizations regarding the NRC's role, as well as the Federal government's role generally, in responding to an emergency at a fixed nuclear facility. Attendees should gain valuable insight into the NRC's emergency response role, concept of operations, interface procedures, and decision-making process. In addition, information will also be presented regarding current and forthcoming assessment tools such as the Emergency Response Data System, Response Technical Manual-91, the RASCAL dose projection model, and Protective Action Decision Making guidance.
