In anticipation of having to repair pressurizer heater sleeves at St. Lucie Unit 1, by a letter dated December 21, 1989 (L-89-464), the Florida Power & Light Company requested review and approval of ASME Code Cases N-432 and N-474-1.

During the 1990 refueling outage of Unit 1, you inspected the pressurizer heater sleeves for leaks and found none in need of repair. Your staff informed us of that fact by telephone in February 1990. As a result of that notification, we have suspended our review process and have done no more work on this issue since that time.

Since there is no active need for this approval at present, we are closing TAC 75541.
