In accordance with 10 CFR 50.90, Florida Power & Light Company (FPL) submits herewith a request to amend Facility Operating Licenses DPR-67 and NPF-16 for St. Lucie Units 1 and 2, respectively.

This line-item Technical Specification improvement was made in accordance with the guidance of Generic Letter 91-01, "Removal of the Schedule for the withdrawal of Reactor Vessel Material Specimens From Technical Specifications".

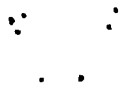
The proposed amendment has been reviewed by the St. Lucie Facility Review Group and the Florida Power & Light Company Nuclear Review Board.

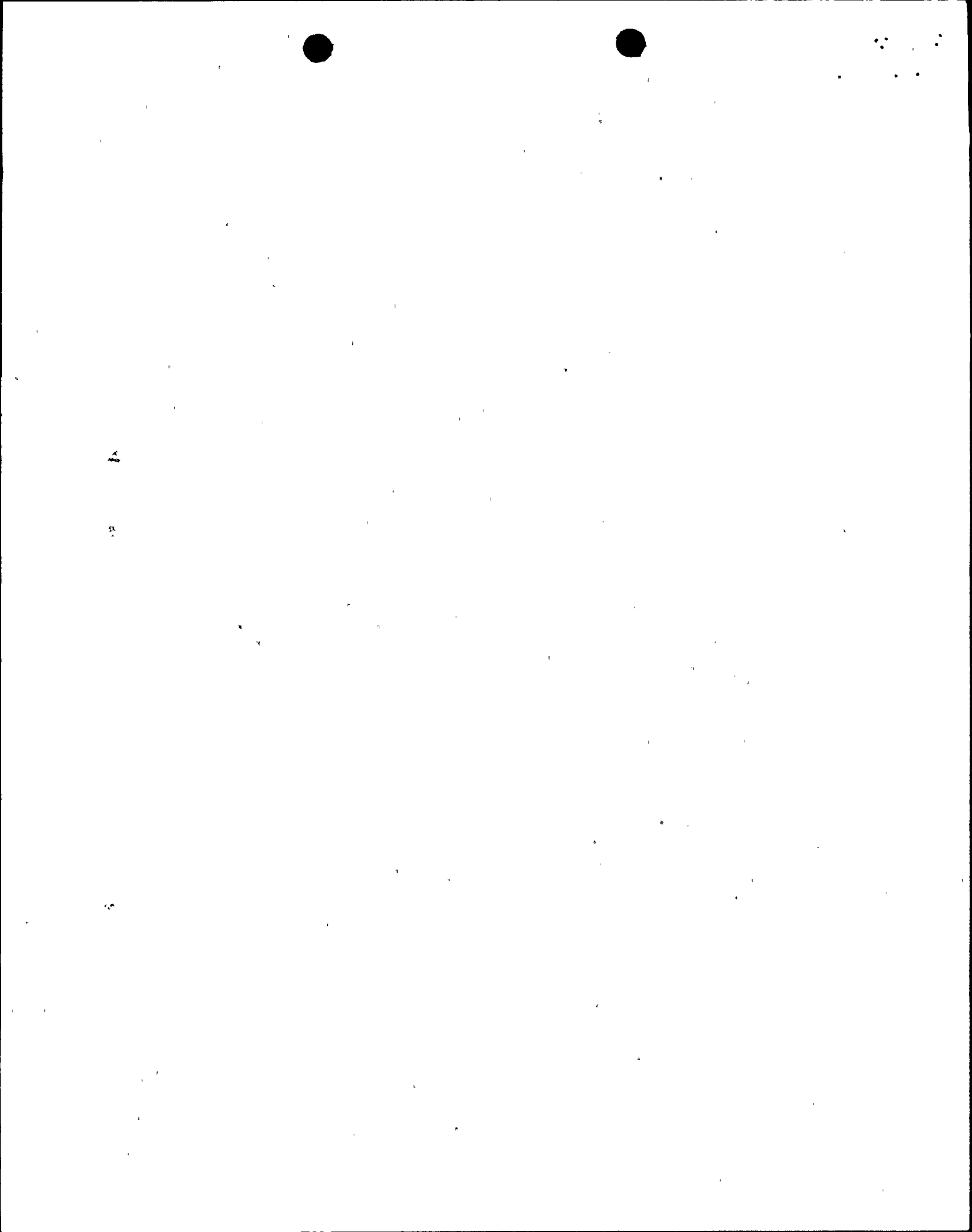


