On June 30, 2017, the U.S. Nuclear Regulatory Commission (NRC) completed an inspection at Virgil C. Summer Nuclear Station Unit 2. The enclosed inspection report documents the inspection results, which the inspectors discussed on July 19, 2017 with Mr. Ronald A. Jones, Virgil C. Summer Units 2 & 3 Vice President, and other members of your staff.

The inspection examined a sample of construction activities conducted under your Combined License (COL) as it relates to safety and compliance with the Commission's rules and regulations and with the conditions of these documents. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

Based on the results of this inspection, no findings of significance were identified.
