

MATERIALS LICENSE

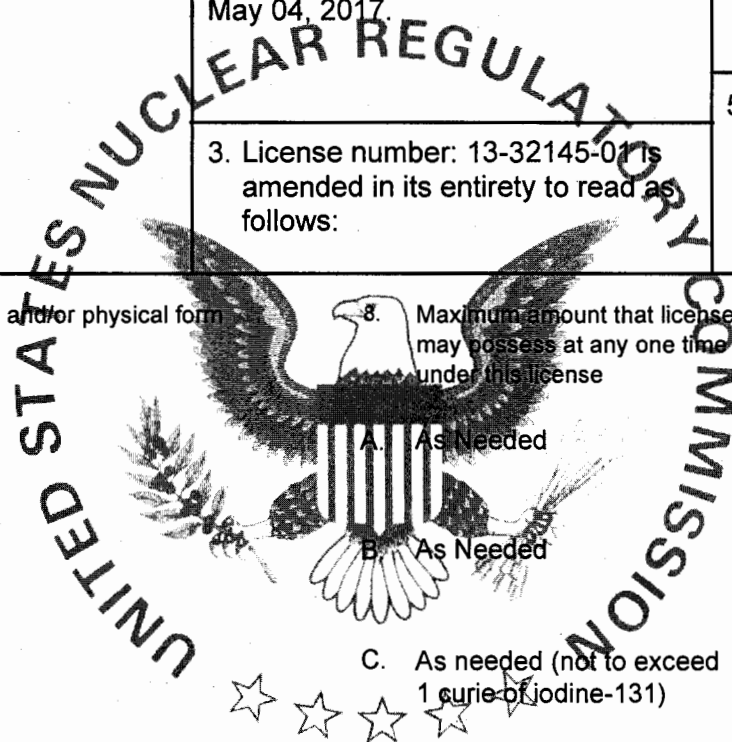

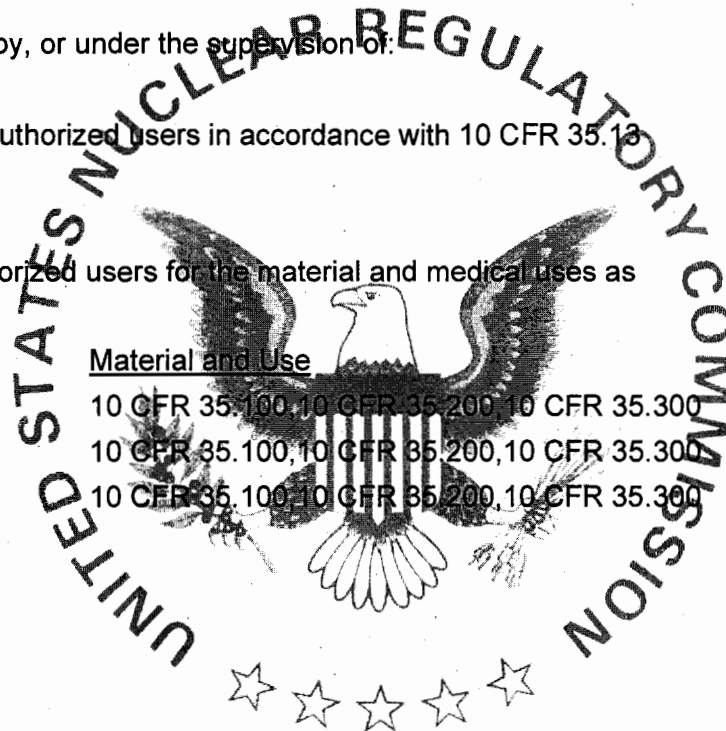
