By letter L-94-018 dated February 28, 1994, Florida Power and Light Company (FPL) requested amendments to Facility Operating Licenses DPR-67 and NPF-16 for St. Lucie Units 1 and 2, respectively. proposed amendments would revise Administrative Controls sections 6.5.2.8 and 6.8.4 of each facility's Technical Specifications (TS), and are considered by FPL to be line-item TS improvements Standard Technical consistent with the Specifications Combustion Engineering Plants, NUREG-1432. Based on conversations between FPL and the NRC Division of Reactor Projects, it was determined that the proposed amendments, relative to their application to the Fire Protection Program audit frequencies, were not acceptable as submitted.

Accordingly, FPL hereby withdraws that portion of the amendment request involving audits of the fire protection programmatic controls, fire protection equipment, and program implementation. Specifically, Specifications 6.5.2.8.f and 6.5.2.8.g should not be modified as shown in L-94-018, Attachments 1 and 2. Rather, these Specifications should remain in their existing form.
