The purpose of this letter is to confirm the completion of the NRC Generic Letter (GL) 96-01 review and procedure changes for St. Lucie Unit 2. In our initial response, L-96-88 dated April 18, 1996, to GL 96-01, *Testing of Safety Related Logic Circuits*, for the St. Lucie Plant, FPL committed to complete the requested review and procedure changes prior to start up from the Unit 2 Spring 1997 refueling outage (SL2-10).

The additional reviews and any necessary procedure changes for St. Lucie Unit 1 are planned to be completed in accordance with our original schedule. The reviews and procedure changes will be complete prior to start up from the Unit 1 refueling/steam generator replacement outage (SL1-15).

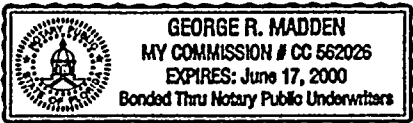
