

Technical Specification 6.9.2 Special Report

On May 7, 1998 the St. Lucie meteorological tower ten meter wind speed indicator was declared out of service due to a loss of indication. It was returned to service on May 15, 1998 and on May 18, 1998, the ten meter wind speed indicator was again declared out of service for the same problem. Unit 1 UFSAR Section 13.8.1.3.1 Action 'b' and Unit 2 UFSAR Section 13.7.1.3.1 Action 'b' states that with a required meteorological channel out of service for greater than seven days, submit a special report to the NRC within the next ten days. As a compensatory measure, all releases of gaseous radioactive material from the radiological waste gas decay tanks at both units used the corrected 60 meter wind speed indicator.

The initial cause of the out of service time was determined to be a dirty connection on the ten-meter wind speed indicator instrument. The ten meter wind speed indicator was returned to service May 15, 1998. However, on May 18, 1998, the instrument lost indication again and was declared out of service. Later on May 18, 1998, the instrument and control technician troubleshooting the loss of indication found a loose ground wire for the ten meter wind speed indicator. The connection was tightened and all other connections were checked to be tight. Operation of the ten meter wind speed indicator was monitored for a few days with no problems, and the ten meter wind speed indicator was returned to service on May 21, 1998.

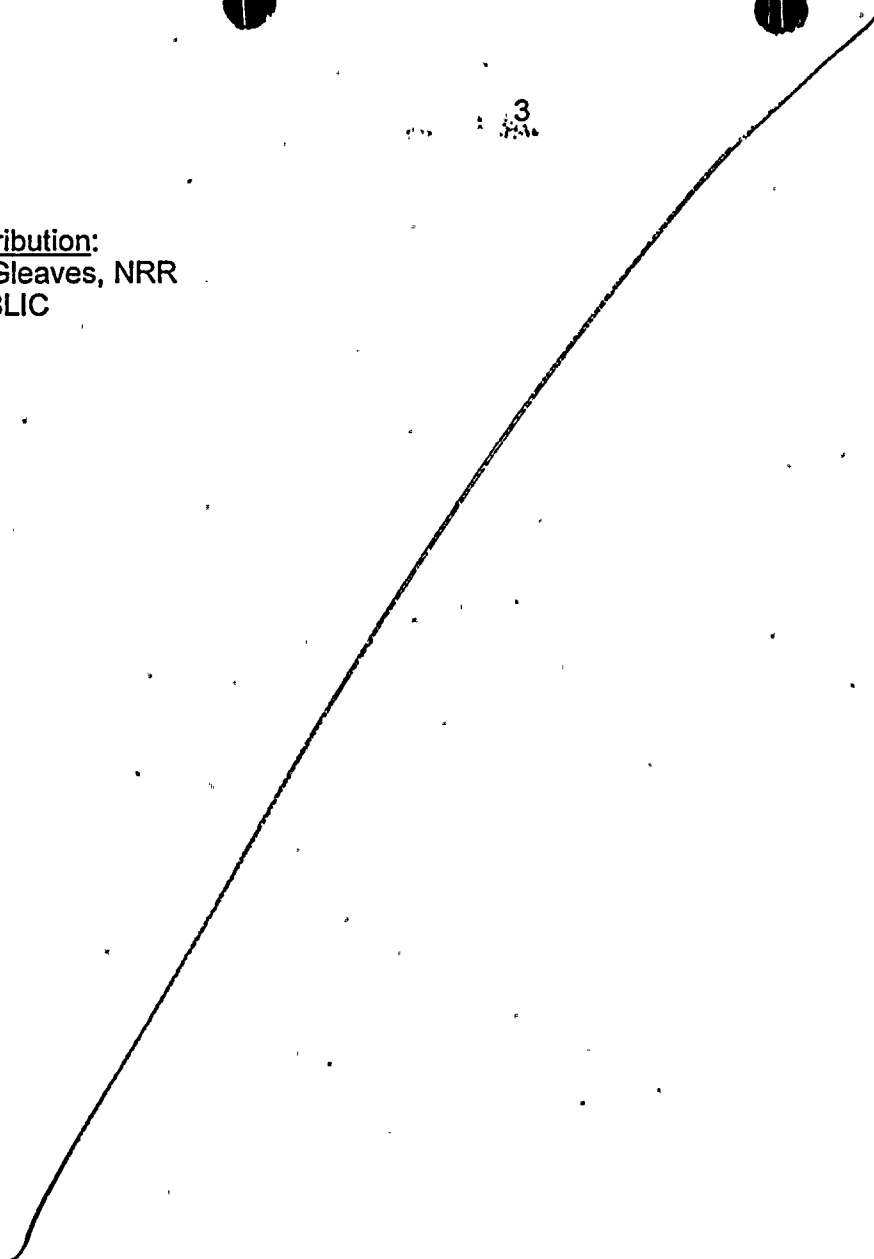
