NRC personnel were available for discussions related to the NRC's 2016 assessment of the Davis-Besse Nuclear Power Station performance, which was documented in the March 1, 2017, End-of-Cycle Assessment letter (ADAMS Accession Number ML17054D122). A handout was available to describe the NRC's Reactor Oversight Process and Davis-Besse Nuclear Power Station 2016 performance.
