On July 13, 2017, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your R. E. Ginna Nuclear Power Plant. The NRC inspectors discussed the results of this inspection with Mr. Scott Wihlen, Director, Site Maintenance, and other members of your staff. The results of this inspection are documented in the enclosed inspection report.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

The NRC inspectors did not identify any finding or violation of more than minor significance.
