- Managing Government Records Directive
- Capture emails of high-ranking officials electronically
- Manage permanent records electronically
- Designate Senior Agency Official
- Agency Records Officer must be trained
- Establish records management training
- NARA requirements

# NARA Bulletin 2017-01

- Agency Records Management Training Requirements
- Minimum requirements for agency records management training programs
  - · Who must take training
  - How often the training must be provided
- Supplements general training requirements in 36 CFR 1220.34.
- Content must include minimum content areas plus content specific to the organization
- Includes promising practices

# Electronic Messaging and Encrypted Messages

- "Records Management Priorities for 2017"
- Electronic messaging and encrypted messages
  - · All electronic messages
  - Includes alias or group accounts
  - · Use of non-official electronic messaging accounts
  - Applications that support encryption or the ability to automatically delete messages
- Managing web records
  - Schedule records and data sets on web sites
- Ensuring all staff are properly trained in RM
  - How often, who, mandatory content


