Dear Mr. Gieck:

By letter dated June 6, 2017 (Agencywide Documents Access and Management System (ADAMS) Accession Number ML17159A532), Umetco Minerals Corporation (Umetco) submitted its 2017 annual financial assurance surety update for its Gas Hills uranium tailings site in Fremont and Natrona Counties, Wyoming.

The U.S. Nuclear Regulatory Commission (NRC) staff has completed its review of Umetco's surety update. Based on this review, the NRC staff approves the proposed revised surety amount of \$1,459,701.06, pending Umetco's submittal of a revised Standby Trust Agreement and Surety Bond to increase the amount of the previously approved 2016 surety amount from \$1,428,283.25 to \$1,459,701.06. The NRC staff's evaluation can be found in the enclosed technical evaluation report. License Condition 55 has been revised to reflect this revised surety amount and a copy of the revised license is also enclosed.

An environmental assessment was not performed for this action as it is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Part 51.22(c)(10)(i).
